Problem 1

Gr. S. came to rest in another city, where she suddenly fell ill. With a high fever, and having a medical insurance policy in hand, she went to a medical institution, which refused to provide her with free medical care.

Questions (task):

- 1. -What legislative document defines the right to receive free medical care for citizens of the Russian Federation?
- 2. -What documents do you need to have on hand, in addition to your medical insurance policy, to receive free medical care outside your place of residence?
- 3. -Which organization should I contact to protect the rights of the insured?
- 4. -Between which participants of compulsory health insurance should mutual settlements be made for medical care provided to nonresident citizens?

Problem 2

The Ministry of Health of the N-region was contacted by gr. A. with a complaint about the refusal of the head of the medical organization to assign him for service.

Questions (task):

- 1. What regulatory documents determine a citizen's right to choose a medical organization?
- 2. How often can a citizen exercise the right to choose?
- 3. Provide a list of specialist doctors who are subject to the right to choose.
- 4. What document defines the selection procedure?
- 5. What is the patient's procedure?
- 6. What actions can a patient take if a medical institution refuses an appointment?

Problem 3

The quality of medical care in a hospital is directly related to the quality of diagnosis of the diseases that caused hospitalization.

Questions (task):

- 1. From the following indicators, select those characterizing the quality of medical diagnostics in a hospital and provide the rationale for your choice:
- lethality;
- percentage of discrepancy between clinical and pathological diagnoses;
- average length of stay of the patient in the hospital;
- disease outcomes.

Problem 4

The patient was in the trauma department of the hospital for a hip injury. After 4 months there was no complete cure.

Questions (task):

Select and justify making the right decision regarding registration of incapacity for work for this patient:

- the certificate of incapacity for work is extended by the attending physician;

- -VK extends the certificate of incapacity for work;
- -the attending physician refers for a medical and social examination;
- the certificate of incapacity for work is extended by the attending physician together with the head of the department.

Problem 5

Child M., 2 years old, was taken by ambulance to the emergency room of a children's city hospital in an unconscious state, with signs of asphyxia. The emergency doctor's preliminary diagnosis: foreign body aspiration. The mother accompanying the child behaves aggressively towards medical workers, prohibits necessary medical interventions (laryngoscopy, bronchoscopy), and verbally and physically influences the medical staff. The child's mother smells of alcohol.

Questions (task):

- Do doctors have the right to provide assistance to a child without the mother's consent? Give a legal basis for the answer.
- What measures can medical workers take regarding the child's mother?
